Condor would like to request to flare the production from the 7" casing due to the fact the pipeline has not yet been connected. DCP is currently working on installation of the pipeline for this well. The installation was estimated to be completed before the need for flaring occured, however some minor setbacks to this accomplishment were encountered. It is anticipated that the pipeline will be completed on or about 8/12/2013. The volume that is estimated to be flared is at 400 mcf/day. The well is not subject to and does not produce any H2S. Please find attached offset well analysis.
