- 6) Bleed off bradenhead, unland casing
- 7) TOO H with 1 1/4" tubing to 457', condition hole
- 8) RU cement crew, pump 131 sxs 15.8ppg "G" neat cement
- 9) Roll hole, POOH with 1 1/4" tubing, land casing.
- 10) SI well overnight, run CBL recording new cement depths
- 11) Clean out hole, retrieve RBP
- 12) RIH 2 3/8" tubing
- 13) Return well to production under pumper guidance
