Comments:

The following describes the interim reclamation procedures and associated mitigation measures performed:

- Previously disturbed areas were re-contoured, slopes were reduced and re-seeded. A uniform vegetative cover density of 80 percent of the pre-disturbance levels has been achieved.
- Areas that were not used for production facilities, access roads, or other production operations have been stabilized with vegetation. Areas still in operational use, such as the well pad and access road areas, were stabilized with the use of permanent physical erosion reduction methods and maintenance will be performed as needed. The location will continue to be monitored for noxious weed infestations and stormwater BMPs.
