COMMENTS:

Bonanza Creek Energy hereby requests approval to plug back and side track our well, State North Platte K-O-36HNB, API No. 05-123 -37669.

This well was spud originally on 8/14/2013 using Ensign Rig 128. The well was drilled to 9652' MD, 6448' TVD. Because of the extended reach of this well from the SHL, the hoisting loads proved to be too high to allow Ensign 128 to finish the well. To avoid getting stuck in the hole, drill pipe was pulled and the rig was moved off the well. A larger rig has been moved on the hole and during reaming to bottom operations, the hole has started to collapse from swelling shales and from a suspected fault. The current problem is occurring at 8100' to 8300' MD. No progress has been made in cleaning out the well for the last 48 hours.

Surface casing: 9-5/8", 36#, J-55 set at 422' and cemented to surface with 370 sacks.

Intermediate Casing: 7", 26#, P-110 set at 7297' and cemented to surface with 555 sacks.

Fish in hole: None

Proposed Plug: 500' plug, 125 sacks, 17.5 #/gal, 0.94 ft3/sack, to be set at 7400'- to 7900' MD

Proposed sidetrack depth: 7500' MD

Proposed Objective Formation for sidetrack: Codell, same as original objective.

BHL target for sidetrack hole: 470' FSL, 2580' FWL, same target as original wellbore.

Verbal approval to plug and sidetrack the original wellbore per the listed procedure was provided to Gary Johnson by Diana Burn on the morning of 09/24/2013.
