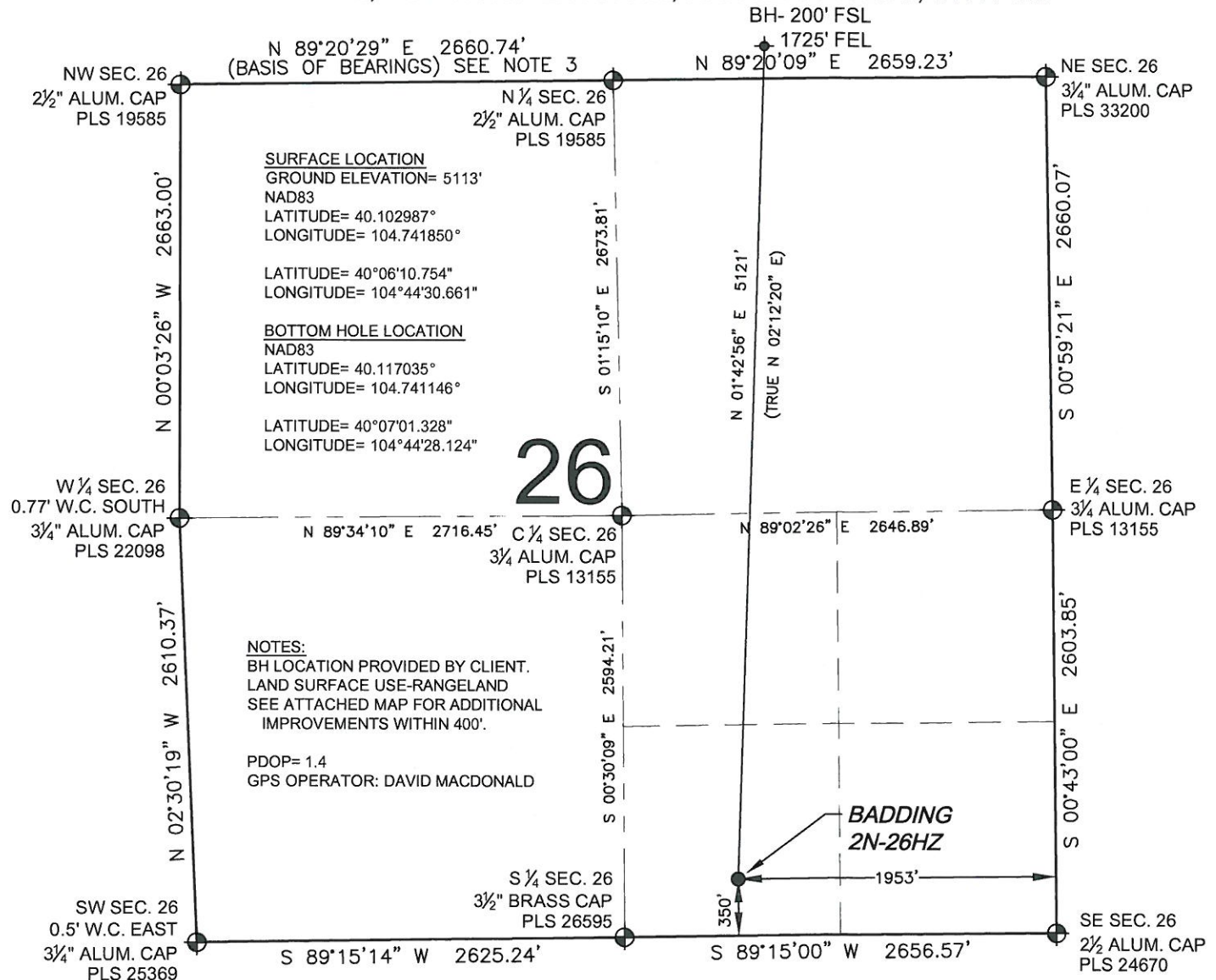


# WELL LOCATION CERTIFICATE: BADDING 2N-26HZ

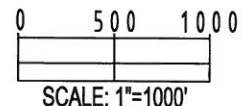

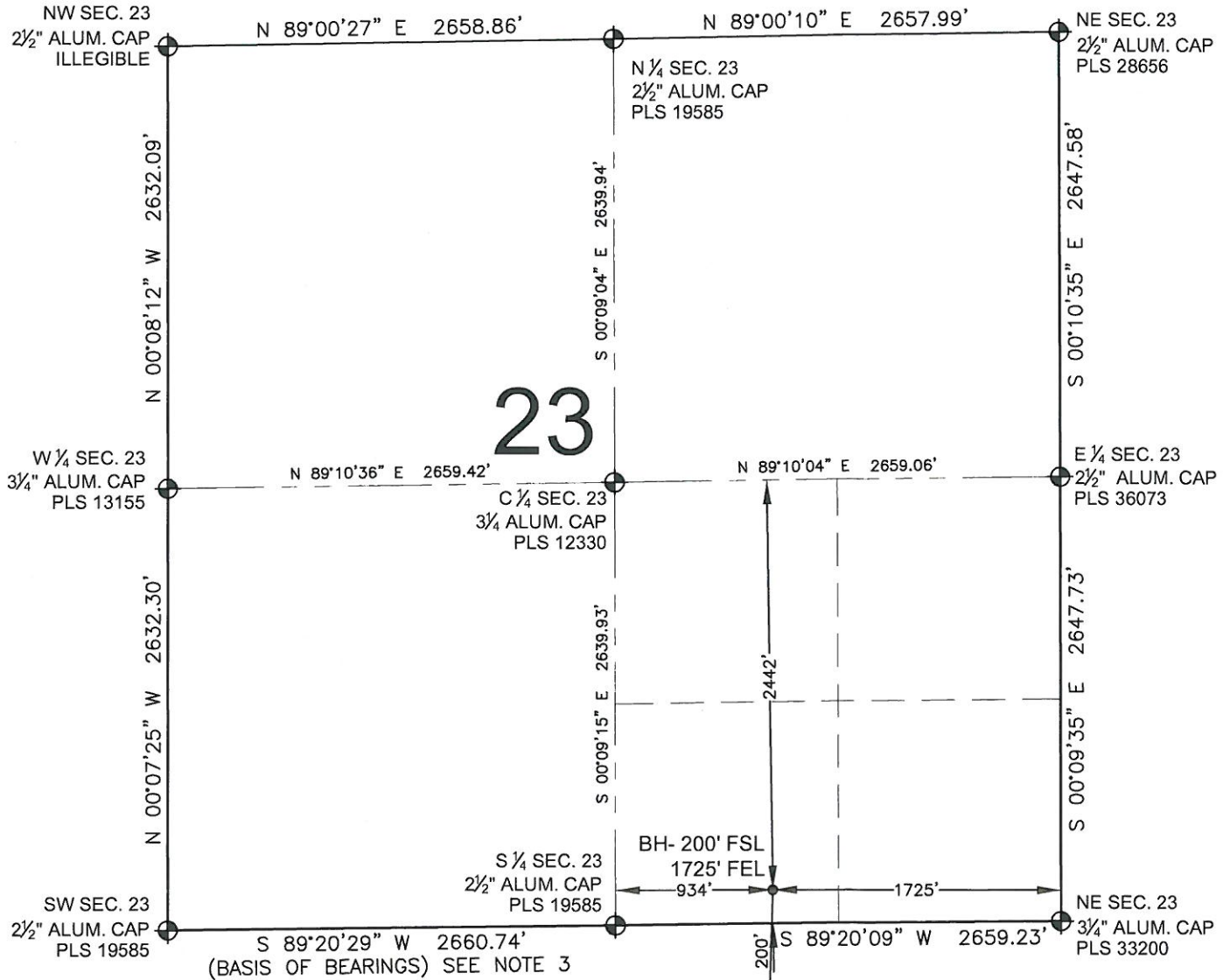

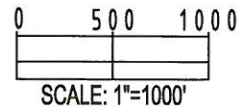
