In regards to your questions, please see the below responses. Also, please note there was a typo in your email and the F26NWM is actually the F25NWB.

Note that Facility ID: 324257 is for the Benzel Disposal well (045-09501), please clarify.- this is the pad for that disposal well, however as a back up , encana will use this pad for water storage, the actual UIC facility ID for the disposal is 159149

Please clarify the locations in which the water will be used. The water from WPX will be used for Encana's completion operations on the I27W, O19EB, K19CNE and J24NW wells

Please clarify the custody points as there is contradiction on the number of transfer points in addition to piping verse trucking. The custody transfer points are the F25NWB and J26NWB (as a back up) well pads. The water from WPX will be trucked to the custody transfer points and then piped to the frac locations.

Please provide the latitude and longitude of the transfer points F25NWB 39.500713/-107.725553. J26NWB 39.49502/-107.74061

Please clarify how the water will be stored at the transfer points and at the locations where the water will be used. Note that the large volume temporary above ground storage tanks shall not be used to store frac water, flowback water, or E&P waste.

Water will be stored in frac tanks

Heather and Karolina,

Please verify the following:

Encana Document Number 400429765:

Includes the Sundry and WPX Transferring Operator Water Reuse Plan which is signed by WPX only.

The Plan states that the water will be transferred from WPXs Facility IDs:

- Parachute Water Treatment Facility, Facility ID: 149015 and piped to the Custody Transfer Point in the SWSW S23, T2S, R96W; or to the Rulison Water Treatment Facility, Facility ID: 149006.R96W

The Plan states that the water will be then be trucked to Encana approved Oil and Gas locations IDs:

- F26NWM Well Pad Facility ID: 423182; and
- J26NWB Well Pad Facility ID: 324257.

Note that Facility ID: 324257 is for the Benzel Disposal well (045-09501).

The Plan states that the water will be collected at either of the two identified WPX Water Treatment Facilities and trucked to either of the two identified Encana Well Pads. (Custody Transfer Points).

The Plan states that from the transfer point, Encana will reuse the transferred water at the following locations:

- Frac Location 1: I27W Pad Location ID: 324383;
- Frac Location 2: O19EB Pad Location ID: 431050;
- Frac Location 3: K19CNE Pad Location ID: 335409; and
- Frac Location 4: J24NW Pad Location ID: 335058.

The Plan states the the Destination of water to be at the following locations:

- F25NWB well pad Facility ID 423182; and
- J26NWB well pad Facility ID 324257.

Note that Facility ID: 324257 is for the Benzel Disposal well (045-09501), please clarify.
