WHEREAS, the lands covered by the Lease are described on the attached Exhibit "A" to this Extension;


WHEREAS, the Lease is still in force and effect; and,

The Lessor does hereby ratify, adopt, and confirm the Lease, in all of its terms and provisions, and does hereby grant, lease, demise, and let said Lease unto the Lessee to be in full force and effect. The Lessor agrees and declares that the Lease in all of its terms and provisions is binding upon Lessor and is a valid and subsisting lease with all payments current and other lease obligations in good standing.

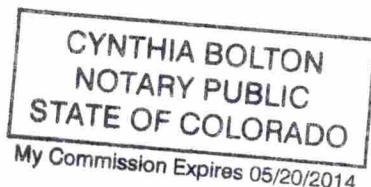
