The attached documents (site maps and analytical data) support the request for closure for the Narco Wattenberg Landfarm, COGCC Facility # 149010, Remediation tracking # 7961. Per the request from the field inspection performed by COGCC on 06/25/13 (document # 667100044, attached) Encana advanced 6 borings on 07/31/13 within the old Narco Wattenberg Landfarm footprint and collected 7 soil samples. Additionally, groundwater samples were collected on 08/05/13 from 5 of 8 monitoring wells at the site; 3 wells were dry (MW-04, MW-07, and MW-08). No soil and groundwater sample concentrations were above COGCC Table 910-1.
