The CT unit has to move off and containment also has to be set on location. We believe the tubing is in a bind and is keeping slickline from being able to pull the plug. We plan on pulling tension on the tubing, rigging up slickline, and seeing if the retrieving tool can reach the plug and pull it out. Then we would land the tubing, nipple down/nipple up, and put the well back online. Mark Weems gave verbal approval for this repair work to take place on the HC-1 on well during a phone conversation with Paul Belanger (Reg. contractor) and Andy Antipas (KM) on October 7th, 2013. Per request we will also phone call Mark Weems to let him know this sundry has been submitted.
