Water Based Drilling Fluids Disposal: KMG will reuse water-based drilling fluids to the maximum extent at which point they will either be land applied or taken to a licensed, commercial disposal site; decided upon based off of laboratory analysis of fluids.

Water Based Cuttings Disposal: Water based cuttings will be used to drill the curve of the well. They will be disposed of using a Centralized E&P Waste Management facility or a private spread field depending on what is feasible at time of drilling.

Oil Based Drilling Fluids Disposal: KMG will reuse oil-based drilling fluids to maximum extent at which point they will be returned to the fluids manufacturer for re-conditioning or disposal at a licensed, commercial disposal site.

Oil Based Cuttings Disposal: KMG will use oil based cuttings to drill the lateral of the well. They will be disposed of offsite and at a licensed, commercial disposal site.
