Dear Director Lepore and Mr. Kerr:

This letter is in regard to John A. Hall's objections ("Objections") as outlined by Hall's counsel in a July 29, 2013 facsimile regarding the Encana Oil & Gas (USA) Inc. ("Encana") Notice of Intent to Propose 1R-100 318A(I).e. boundary line wells for the Minch 0-6-4, Minch 0-4-4, and the Minch 0-5-4 wells (collectively referred to as "Wells").

In an August 8, 2013 letter, our firm responded to each of the Objections set forth by Mr. Hall and invited Mr. Hall to engage in a discussion with Encana regarding his Objections to the proposed Wells. Despite this invitation, Encana has not heard from Mr. Hall since his initial July 29, 2013 facsimile. Because of this, Encana hereby requests that the Commission staff dismiss the Objections proffered by Mr. Hall and confirm that Encana is able to proceed with permitting the Wells via the normal permitting process.

In the alternative, if the Commission does not dismiss Mr. Hall's Objections, Encana hereby requests a hearing before the Commission per COGCC Rule 318A.e.(6).C at the October 28, 2013 regularly scheduled Commission hearing.
