A geologic fault zone combined with an unknown depth of fish has resulted in the need to sidetrack. ii. 8059ft MD is the total measured depth reached in the wellbore being abandoned. iii. 9 5/8" 36# J55 LTC set at 1314ft MD, 7" 26# P-110 LTC set at 7461ft MD iv. Top and bottom measured depths of fish are unknown. Varel 513 bit (1ft length) and discovery 4.75" motor (28.75ft length) were left in hole. v. There are no proposed cement plugs as this is planned as an open hole sidetrack. vi. There will not be any cement pumped. vii. The proposed depth to kick off and side track is 7504ft MD. viii. The proposed objective is the same – Niobrara. ix. The BHL is the same as the wellbore being abandoned.
