Ursa Operating Company, LLC respectfully requests permission to change the BHL of the subject well. To correspond with the new total depth of 5929' (MD) and 5776' (TVD), Ursa would like to make the following update to the proposed casing/cement program for the BAT 13C-24-07-96 well:

Production: In a 7-7/8" hole, set 4-1/2" production casing set at 5929' (TD) and cement from TD to >500 feet above top of gas using 548 sacks of cement.

Please be advised that the mineral lease description and lease acres for the new proposed BHL is the same as originally permitted. The spacing unit information has not changed. The distance to the nearest well in the same formation was measured from BAT 13D-24-07-96.
