

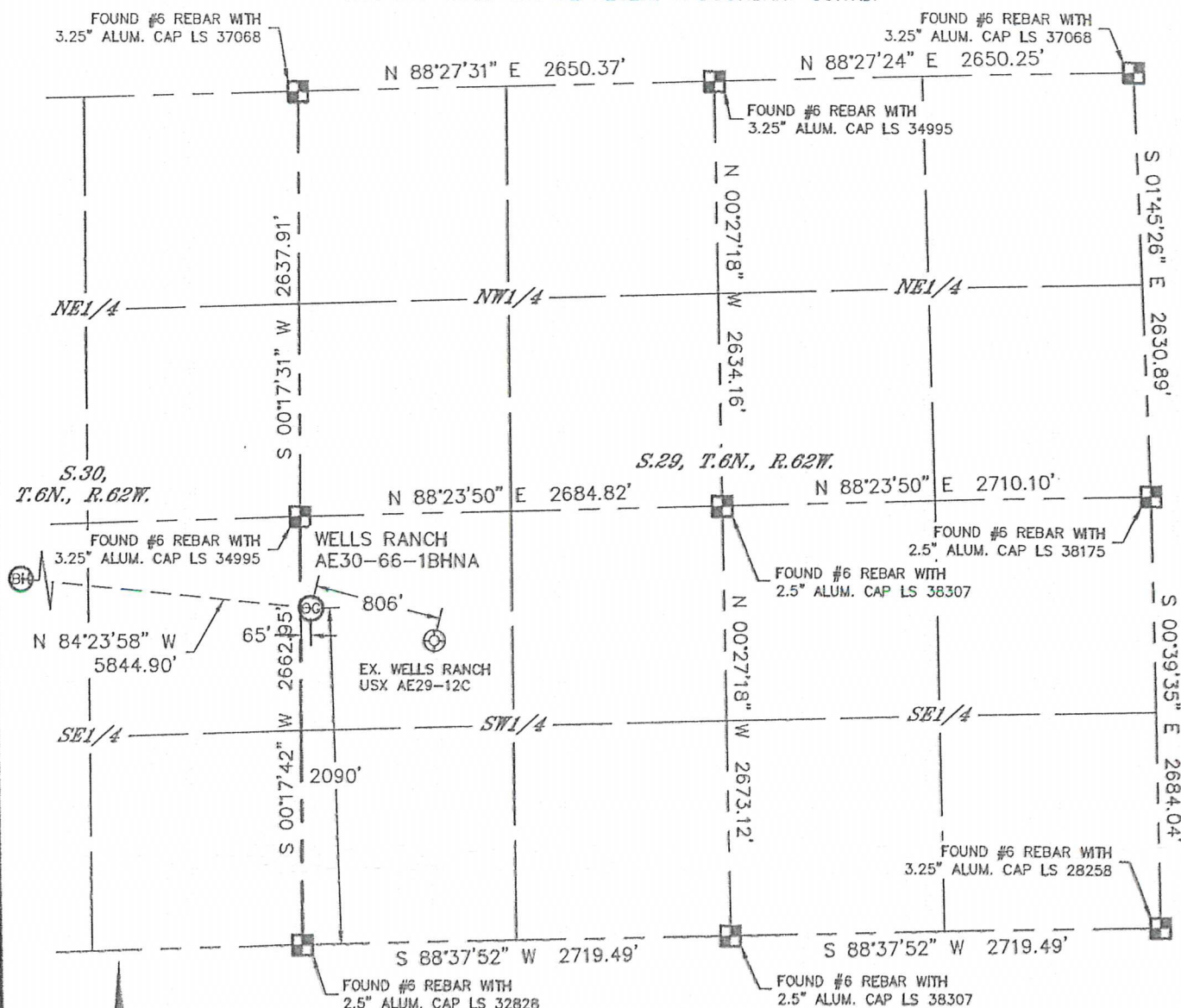

In accordance with a request from Preston Foster with Noble Energy Inc. Lat40°, Inc. has determined the surface location of the WELLS RANCH AE30-66-1BHNA to be 2090' from the SOUTH line and 65' from the WEST line as measured at right angles from the section lines of Section 29, Township 6 North, Range 62 West and the bottom hole to be 2475' from the NORTH line and 385' from the EAST line as measured at right angles from the section lines of Section 25, Township 6 North, Range 63 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 8/1/2013, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

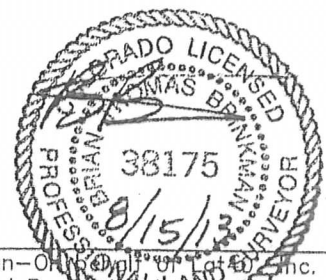
