Details of work:

Control well w/ 20 bbls kill fluid. RIH w/ blade bit, and scraper, 220 jts. Tagged fill at 6788' KB. TIH w/ RBP, retrieved head, 214 jts 2 3/8" tubing. Set RBP @ 6610' KB w/ 216 jts. Spot 2sks of sand. Pressure test to 1500#. Roll hole. Unland casing. Pick Up mule shoe and TIH w/134 jts of 1 1/4" to 4255'. Test lines to 5000 psi. Pump 5bbl ahead. Pump 250 sks of "POZ" neat 13.5 ppg cement from 2330' to 4150'. Reland casing. Test lines to 500#. Bond log from 5000' to surface. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 2 3/8" 4.7 # J-55 tubing to 6776' KB. Rig down and move off.
