Inlet 4" ball valves to flow lines are closed and have blind flanges on them.  
All tubing and casing 2" ball valves are shut and plugged.  
WPX currently does not have plans to return the well to injection but would like to have the potential to flowback the well in the event additional water is needed during completions operations.  
This option is preferred over exercising our water right and using a fresh water source .  
Automation Equipment was removed. Injection was ceased on 4/23/13 and equipment removed on 6/18/13.
