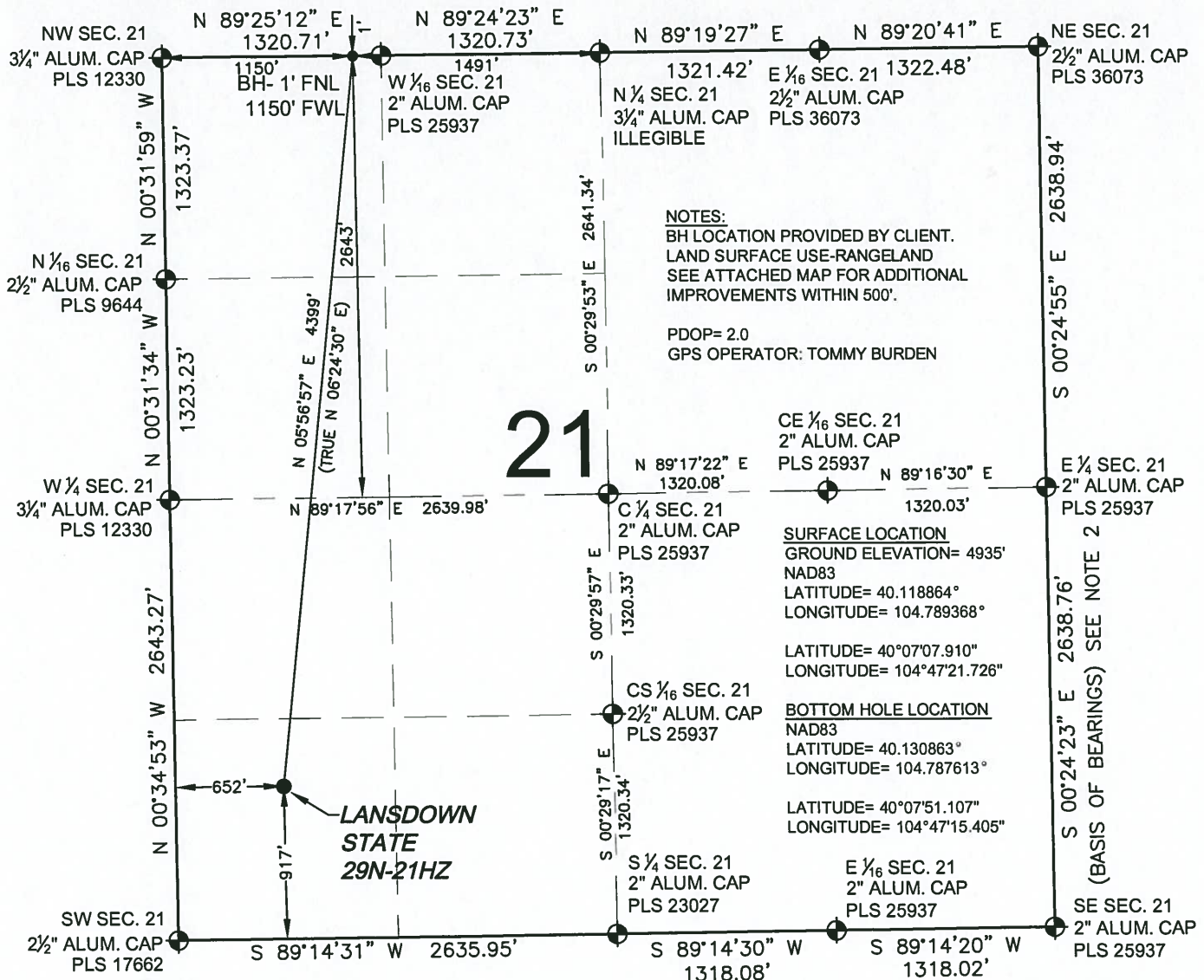


WELL LOCATION CERTIFICATE: LANSDOWN STATE 29N-21HZ

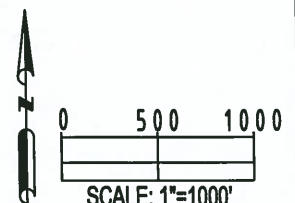
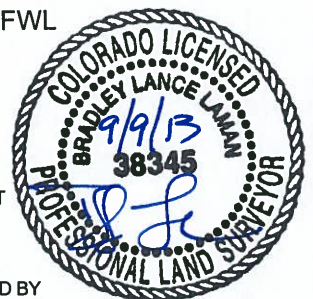
