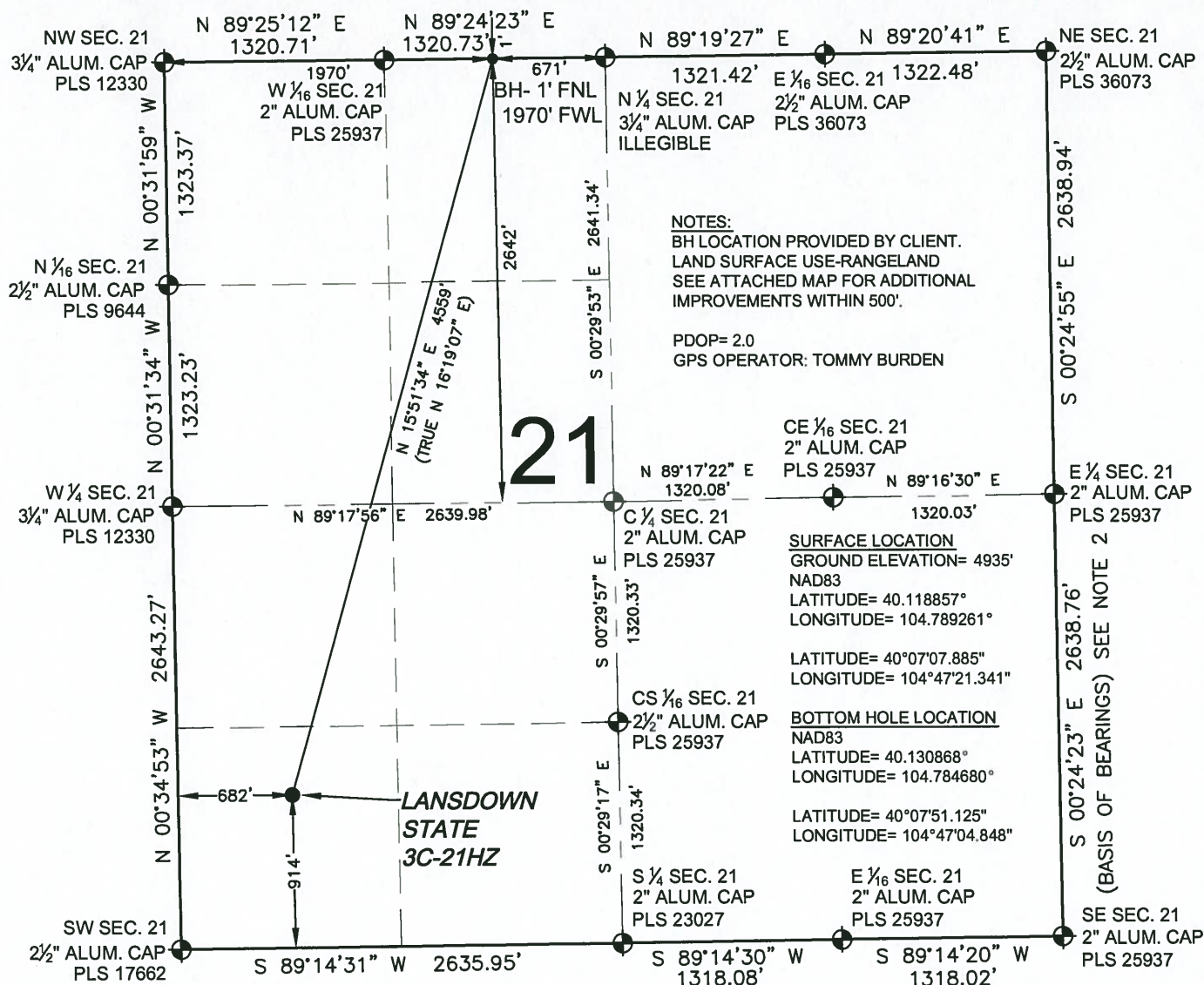


WELL LOCATION CERTIFICATE: LANSDOWN STATE 3C-21HZ

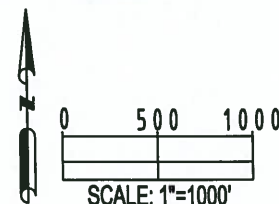
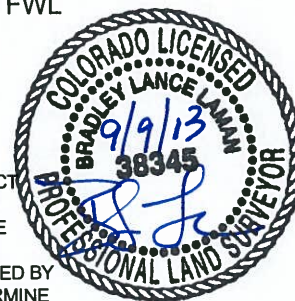
