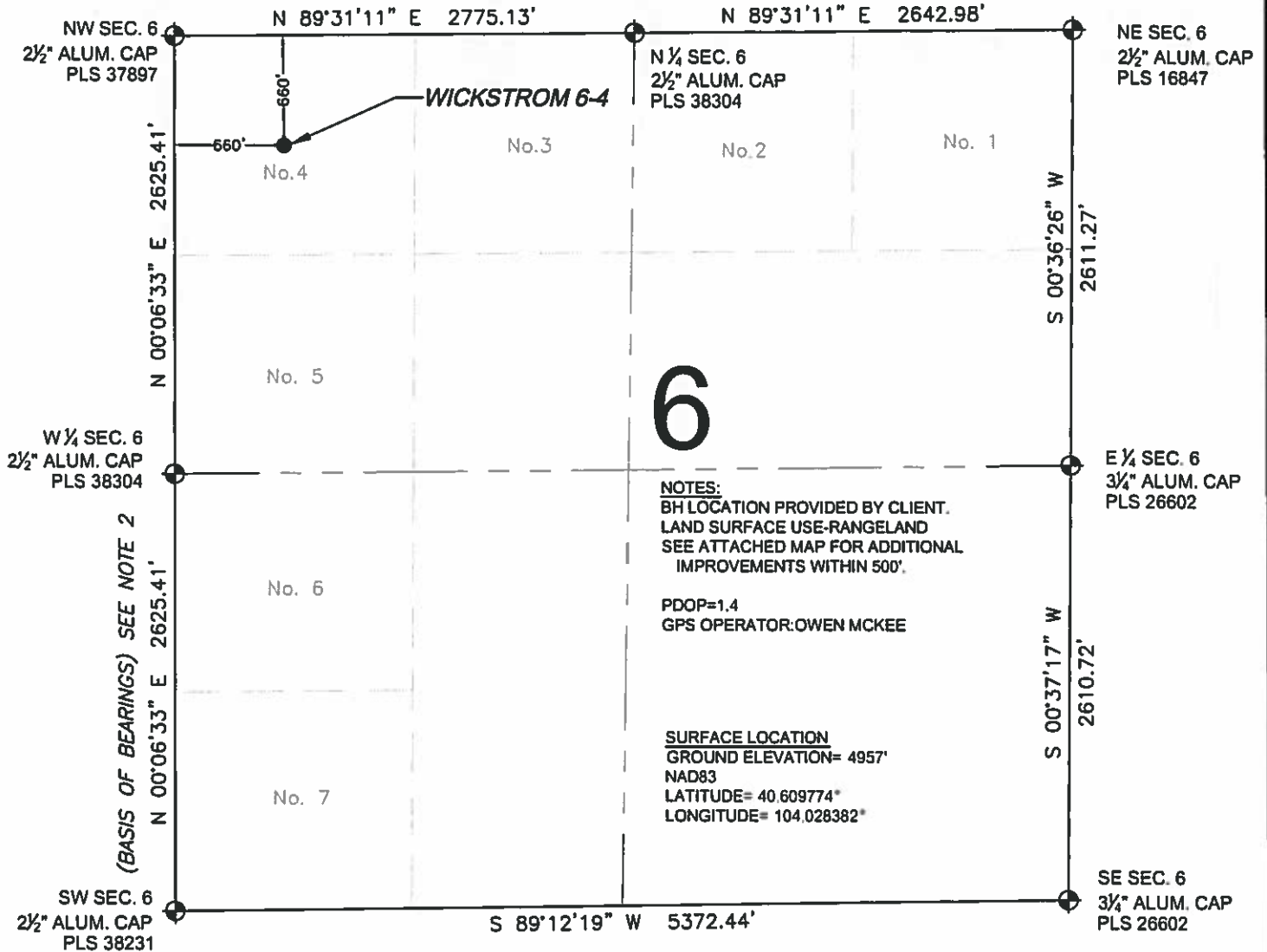


WELL LOCATION CERTIFICATE: WICKSTROM 6-4
