Re: Rule 502.b. Variance Request from COGCC Rule 305.a(2)

Director Lapore,

Kinder Morgan is requesting a variance to the 30-day Pre-Application Notification required by Rule 305.a(2) for the Doe Canyon Compressor Station for the following reasons:

- 1. The Doe Canyon Compressor Station has been operating since 2008 and had passed the Dolores County permitting process prior to construction.**
- 2. All Dolores County constituent concerns regarding the Doe Canyon Compressor Station have been addressed by Kinder Morgan via Dolores County public hearings.**
- 3. The 2012 Doe Canyon Compressor Station Expansion Project passed the Dolores County permitting process. There is currently a Land Development Agreement for the Expansion Project in place with Dolores County, which addresses County concerns and responsibilities assigned to Kinder Morgan.**
- 4. The Dolores County permitting process involved a public pre-application meeting, a public hearing before the Dolores County Planning Commission, and a public hearing before the Dolores County Board of County Commissioners. For the public hearings, the following actions were taken:**
 - Public Hearing before the Planning Commission**
 - 21 days prior, notification sign posted upon property of proposed development.**
 - 14 days prior, letters of notification mailed to landowners within .5 mile radius of the property line.**
 - A legal notice was published in the local newspaper at least twice with information about the public hearing. The public was invited to attend and comment.**
 - Public Hearing before the Board of County Commissioners**
 - 30 days prior, notification sign posted upon property of proposed development.**
 - 30 days prior, letters of notification mailed to landowners within .5 mile radius of the property line.**
 - A legal notice was published in the local newspaper at least twice with information about the public hearing. The first notice was published at least 30 days prior to the meeting. The public was invited to attend and comment.**

5. In all cases, a copy of the application was made available to the public at the Dolores County Courthouse.
6. Please note the certified mailing receipts for landowner notification letters on page 3 of this document.
7. The Operator is the owner of the parcel upon which the Doe Canyon Compressor Station and Expansion project has been developed.
8. Kinder Morgan has consulted with all concerned neighbors personally to address any and all concerns. Landowner consultation remains an ongoing process and Kinder Morgan has since complied with all Dolores County requests for mitigation testing.
9. The remainder of the Form 2A process will be duly completed. An OGLA notification will be sent upon receiving confirmation of Form 2A completeness and a statutory notice will be issued at least 30 days prior to the beginning of construction.

Kinder Morgan believes that between the Dolores County permitting process and its own efforts to communicate with neighboring landowners, all health, nuisance, and general information requirements associated with Rule 305.a(2) have been addressed with the public.

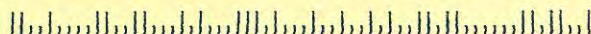

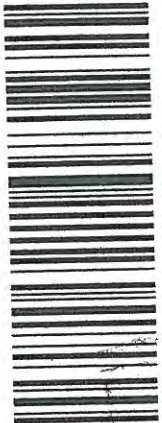

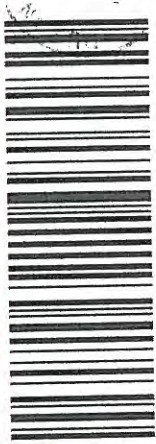
