WPX Energy requests permission to making design changes to the GM 701-28 HN1. The drilling design changes are as follows:

Surface casing will be 13-3/8" 68# P-110 BTC instead of 13-3/8" 72# P-110 BTC. This does not change the cement design

Intermediate hole size is increased to 12-1/4" from 9-7/8"

Intermediate casing size is increased to 9-5/8" 47# HCP-110 LTC from 7-5/8" 33.7# HCP-110 LTC. Casing will be ran to 10,500'.

Intermediate casing cementing will be done with a stage tool placed at 4900'. 1st stage cement will have 1154 sacks of cement pumped from 10,500 to 4900'. 2nd stage cement will have 576 sacks of cement pumped from 4900' to 1935'

Production hole size is increased to 8-1/2" from 6-1/2"

Production casing size is increased to 5-1/2" 23# HCP-110 DQX from a mixed string of 5-1/2" 23# HCP-110 DQX and 4-1/2" 15.1# HCP-110 DQX

PRODUCTION casing cement will have 1066 sacks of cement from 16,317' to 9500'

All casing and cementing changes still meet design criteria (collapse, burst and tensile)
