Hi David,

I left you a voicemail earlier today regarding Encana's plans to re-enter the existing Dreyer 1 (API 05-123-08551) well located in Section 31-T1N-R65W. The reason for this re-entry is to adequately re-plug the well to allow completions of the horizontal offsets on the Louchbouie lease. The waiver of the 20-day comment period is requested in order to move forward with the horizontal drilling program.

Since this is my first request under the new COGCC rules, I'm unaware of any process you may have in place for these types of requests. Since the Director at the COGCC, Matt Lepore, is requesting a waiver from the LGD, which in the case of the Dreyer 1 is you, is it possible for you to write the waiver and send to me via email as soon as you are able?
