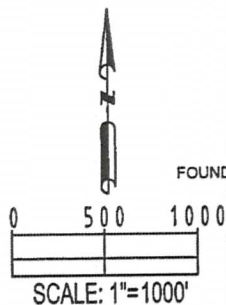
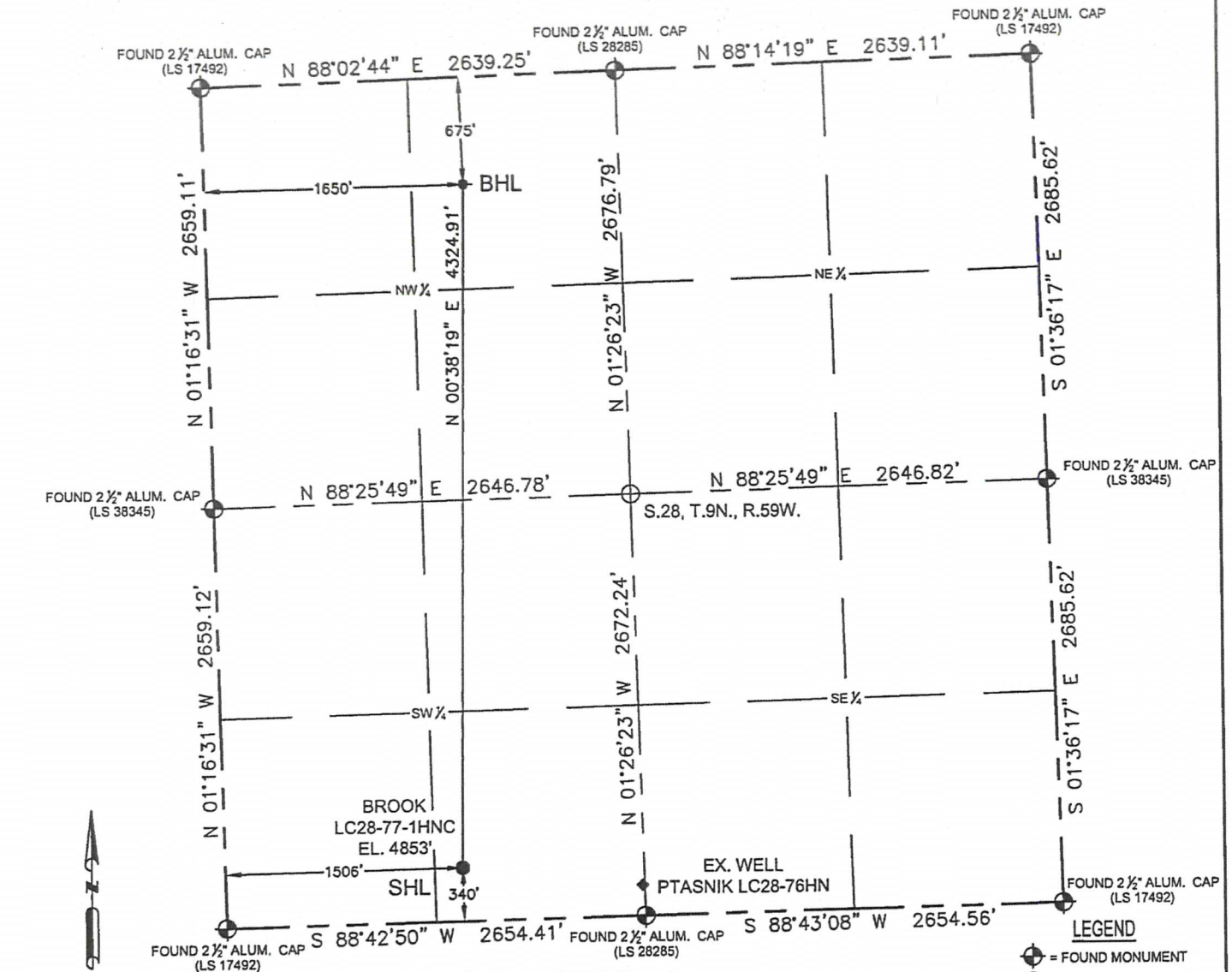


WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the **BROOK LC28-77-1HNC** to be 340' from the SOUTH line and 1506' from the WEST line and the bottom hole to be 675' from the NORTH line and 1650' from the WEST line as measured at right angles from the section line of Section 28, Township 9 North, Range 59 West of the Sixth Principal Meridian, County of WELD, State of Colorado.

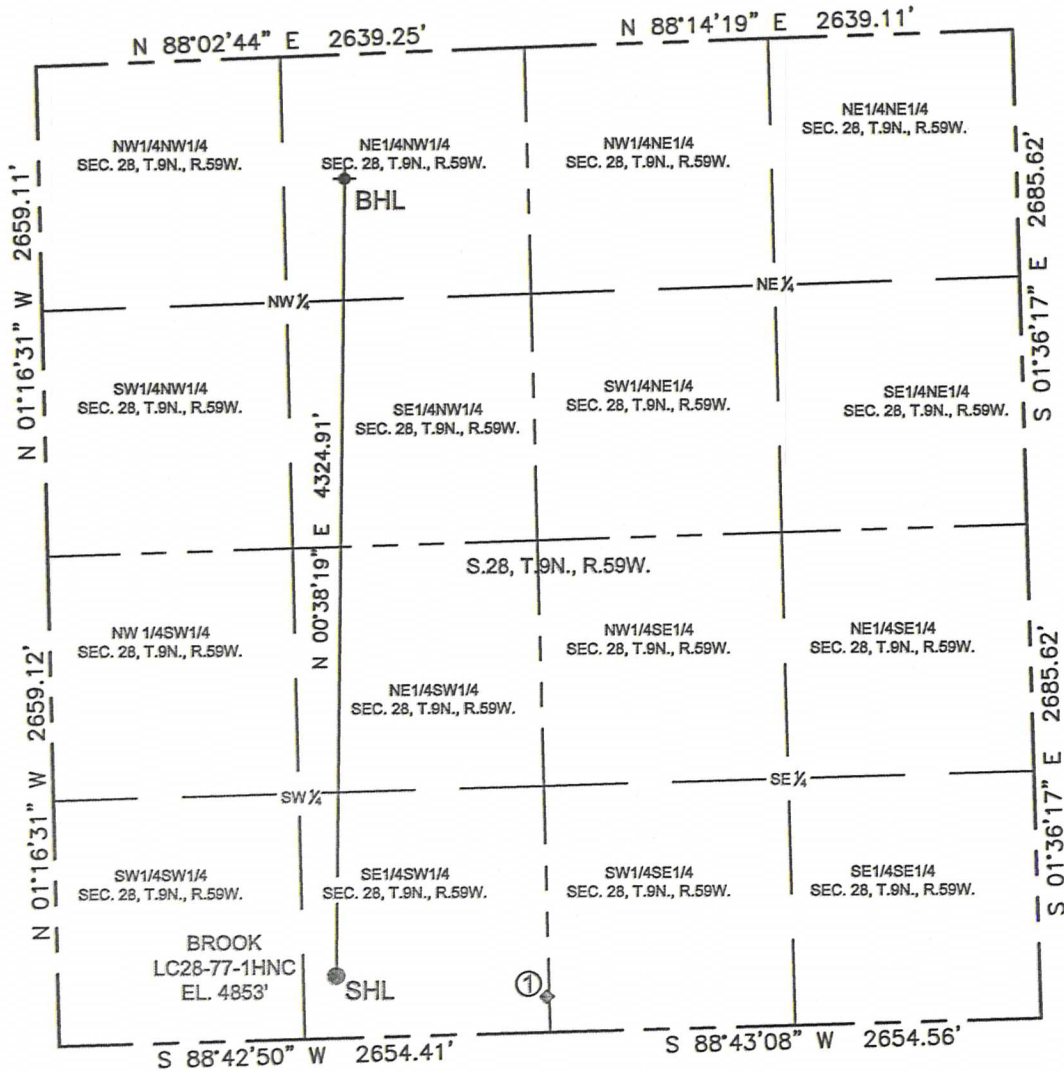

BROOK LC28-77-1HNC

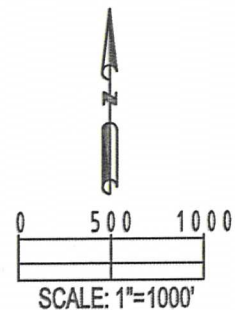
