#### COMMENTS:

We propose to set our surface pipe deeper than originally permitted to  $\pm 764$  ft MD/TVD. After talking with other operators there is a potential for hole instability in this area. Deepening the surface should put potential instability behind pipe before drilling the intermediate section of the wellbore. Please see attached wellbore schematic for additional details.
