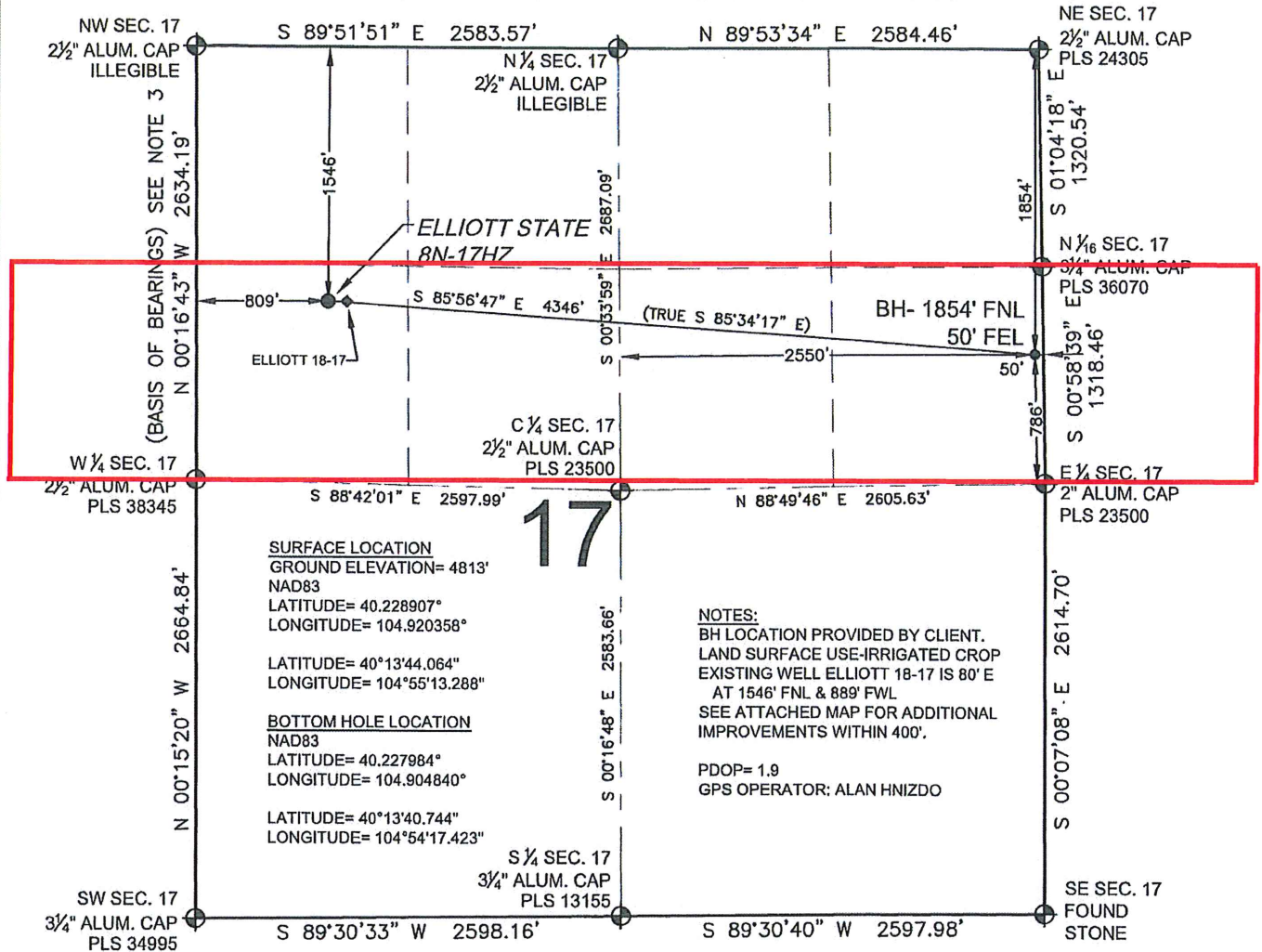

WELL ELLIOTT STATE 8N-17HZ TO BE LOCATED 1546' FNL AND 809' FWL

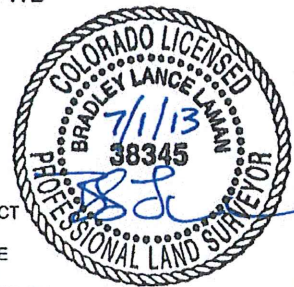

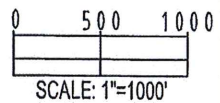
