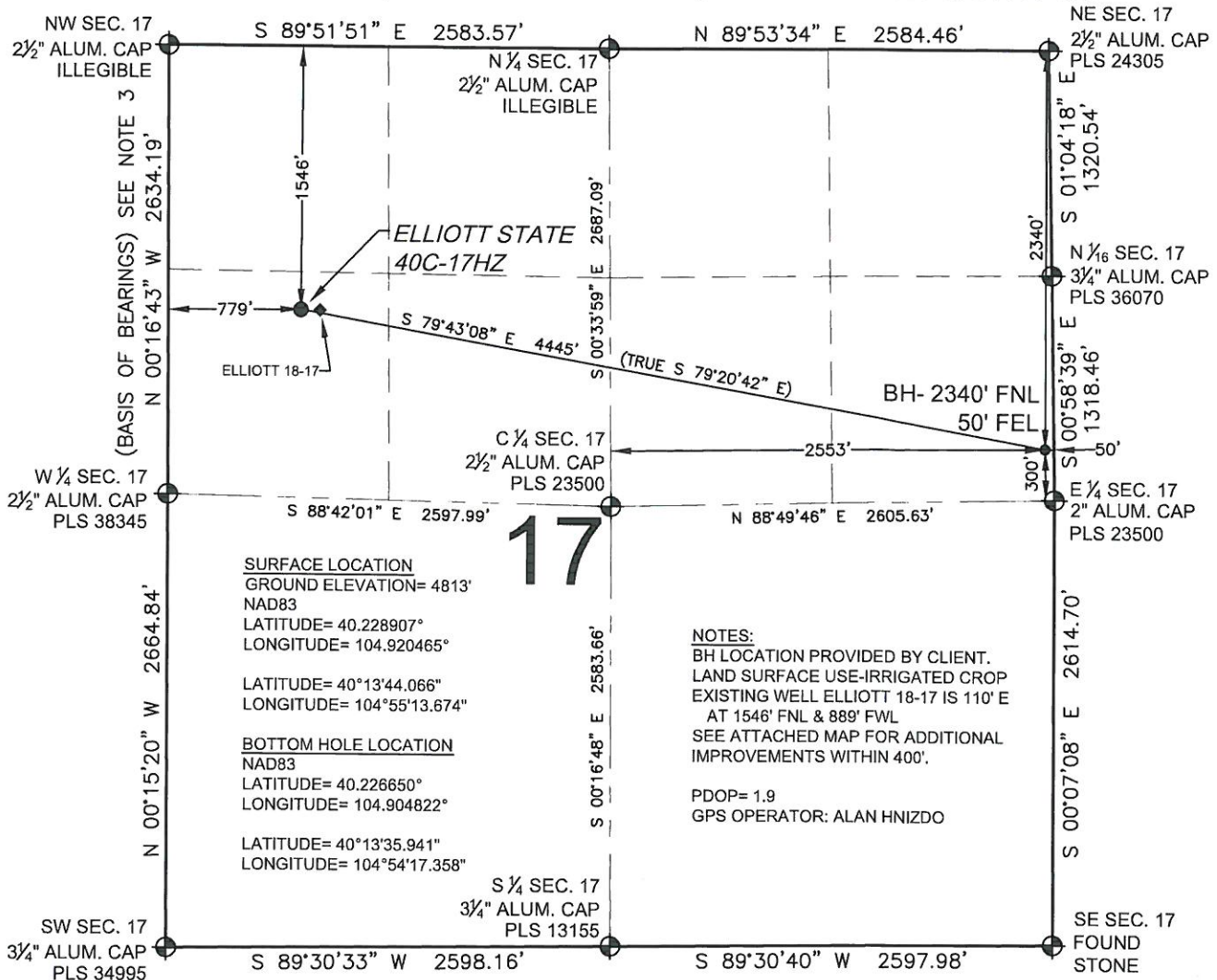


WELL LOCATION CERTIFICATE: ELLIOTT STATE 40C-17HZ

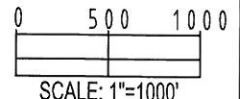
