#### COMMENTS:

While drilling the curve for this well it was determined that the build rates were not effectively made. After KOP it was determined that the drill bit would not land the curve into the Niobrara target at 5,965' TVD, but rather at a lower TVD of 6,430' TVD. Therefore, pumping a cement kick off plug was required to plug back the curent portion of the curve in able to kick off higher at 5,354' TVD to re-drill the curve to 5,965' TVD. The wellbore from 5,976' up to 5,950' MD (bottom of cement plug), will need to be abandoned.
