COMMENTS:

WPX requests permission to squeeze the GM 702-4-HN1 again because the first squeeze did not give a top of cement above the retainer and we are not confident the bradenhead has been remediated. I spoke with Shauna and she gave me verbal to squeeze. I also talked to Jay and he gave me verbal approval as well.

We ran the CBL today and did not see any cement above the retainer. We had 2100 psi on the bradenhead this morning, but have since bleed it off and shut the bradenhead back in to see if the pressure builds again, or if it was just a trapped gas bubble. Historically, the bradenhead pressure has built inconsistently and it could be a few days before we see any pressure, if at all.

After the squeeze, we will run a CBL and monitor bradenhead pressure. If we see a cement top and bradenhead pressure has been eliminated, we will submit the CBL for your approval and proceed with the side track as planned. If the proposed plans for the side track change, we will submit another sundry with the updated proposal.
