My engineer has provided the following information:

The above ground power line ends 150 feet from the back of the pumping unit and 180 feet from the polish rod/well head. Also the power pole is located outside of the well location and was install in accordance with State regulation and OSHA regulations. The power line is buried from the power pole to the pumping unit and is in a no dig zone. The above ground power line is outside the reach of any guide wires that would be set up in the event of a service rig is working on the well so that there is no way that any guide lines/wires can be draped over the above ground power lines. Also in the event that any work need to be performed to this well or any well we follow all OSHA lock out tag out rules.
