COMMENTS:

Encana requests the approval of a temporary water storage facilities location that would place two 150' diameter water storage tanks next to the existing 8 acre well and facilities site. The tanks will fit inside the 6 acre area designated for temporary completions that was agreed upon in the SUA. The location is on cropland.

The surface owner has already given their approval for this site through the signed Surface Use Agreement that was submitted with the permit.

There are two options for water sources for this location. Encana's first option is for a third party contact to pipe water in from a hydrant. The second option is trucking water to the location.

Encana will agree to the following as conditions of approval for this temporary water storage location:

1. Large volume temporary storage tanks will not be placed on fill material.
2. Only fresh water is permitted to be stored in large volume temporary storage tanks; flowback or produced fluids shall not be placed in large volume temporary storage tanks.
3. Any tanks containing flowback and/or produced fluids shall be placed on a sufficiently impervious area of the pad with adequate secondary containment.

Estimated location construction would begin October 1st, 2013 and the tanks would be removed immediately after the frac operations are completed.
