COMMENTS:

WPX ENERGY requests the following changes to the hole size and casing size for this well. Surface casing and cement volumes stay the same. Intermediate hole size is increased to 12-1/4" from 9-7/8". Intermediate casing increases to 9-5/8" 47# HCP-110 LTC from 7-5/8" 33.7# HCP-110 LTC. It will be set at 10,300' md. A stage tool will be placed at 4500'. The first stage will use 1219 sacks of cement with the bottom being at 10,300' and the top being at 4500'. The second stage will use 644 sacks of cement, with the bottom being at 4500' and the top being at 1152'. Production hole size is increased to 8-1/2" from 6-1/2". Production casing increases to 5-1/2" 23# HCP-110 DQX casing throughout the entire well. The cement job will use 1229 sacks of cement with the top being at 9300'.
