I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comment.

During my review, the distance the nearest High Occupancy Building Unit and Designated Outside Activity Area is greater than one mile. Therefore, I will change the distance to the nearest High Occupancy Building Unit and Designated Outside Activity Area from 1,001 feet to 5,280 feet.

Please send me a revised Location Drawing that more accurately lists the distance to these two Cultural features. You may hand edit the Location Drawing if you'd like. For future 2A submittals please report the nearest distance to all Cultural features out to 5,280 feet.
