In order to comply w/air permitting a planned cold vent will not be placed on this location. Noble Energy will need to add four (4) additional VOC burners instead bringing the total to 11. This change will not modify the surface disturbance identified on the approved 2A (doc #400380440). All documentation submitted with the 2A, approved 5/15/13, is still valid. An updated equipment inventory is attached. As noted on the 2A the existing EFM is to be moved during construction to the proposed facility location. The equipment inventory has been updated to reflect that.
