WPX Energy Rocky Mountain, LLC requests to extend the Water Reuse Plan between WPX Energy and Encana for a period of 180 days. The current agreement (DOC #2145398) is set to expire on 12/25/2013.

Encana anticipates a need of up to 200,000 bbls of water from WPX Energy over the next 6 months.

WPX Energy and Encana are currently working toward a long term perpetual water sharing agreement for this area. The requested extension is necessary in the interim to provide WPX Energy and Encana the time necessary to complete the perpetual agreement. WPX Energy and Encana will continue to operate in compliance with the conditions of approval associated with DOC #2145398.
