Venessa,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have a few comments.

1) Based on our phone conversation earlier today, I will change the Facilities section of the Form 2A so that it does not indicate there will be any Temporary Large Volume Above Ground Tanks at this location.

2) A review of the Facilities section and the Facility Layout Drawings indicates the types and number of facilities do not match each other. For example the Facility Layout Drawing shows a 500 gallon glycol tank and a 500 gallon oil tank but they are not listed in the Facilities section of the 2A and the Facilities section lists one Flare but it is not shown on the Facility Layout Drawing. Please provide me with a complete and accurate list of the facilities planned at this location and if necessary a revised Facility Layout Drawing.
