Mr. Cohen:

Please refer to that certain Surface Use and Damage Agreement dated November 12, 2010, which is attached as Exhibit "B" ("SUA") to that certain Oil and Gas Lease dated effective November 12, 2010 ("Lease") by and between East Side Sunset, LLC ("Sunset") as ("Owner" under the SUA and "Lessor" under the Lease) of the above described lands and Anadarko E&P Company LP ("Anadarko") as ("Operator" under the SUA and "Lessee" under the Lease).

Burlington Resources Oil & Gas Company LP ("BROG"), a wholly owned subsidiary of ConocoPhillips Company, is successor in interest to Anadarko as Lessee under the Lease and Operator under the SUA. Subsequently, Sunset and BROG have executed an Amendment to the SUA dated effective September 26, 2013 ("Amendment").

The oil and gas operations area will be larger than anticipated at the time of BROG's previous consultation with Sunset on this matter. There are currently no operations on site. Pursuant to the terms of Paragraph 2.(a) of the SUA, as amended, this letter is to serve as evidence of consultation by Operator, and consent by Owner, as to the Oil and Gas Operations Areas (as defined in the SUA) for the Sunset 4-65 21-22 1H and Grimm Motocross 4-65 23-24 1H wells as depicted in the attached surveyed Location Drawing, which is attached to this letter as Exhibit "A".

By execution of this letter, Sunset acknowledges receipt of a lump sum payment of \$10,000.00 prior to the date hereof as compensation for the rights granted in the Amendment.

If you are in agreement with the foregoing, to acknowledge consent to the referenced Oil and Gas Operations Areas and Grantor's receipt of the referenced consideration for the Amendment, please sign below on the duplicate originals of this letter and return one original to the undersigned.

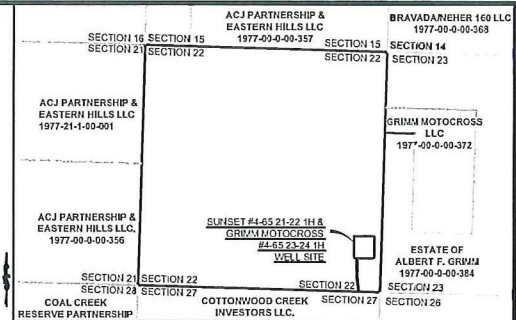

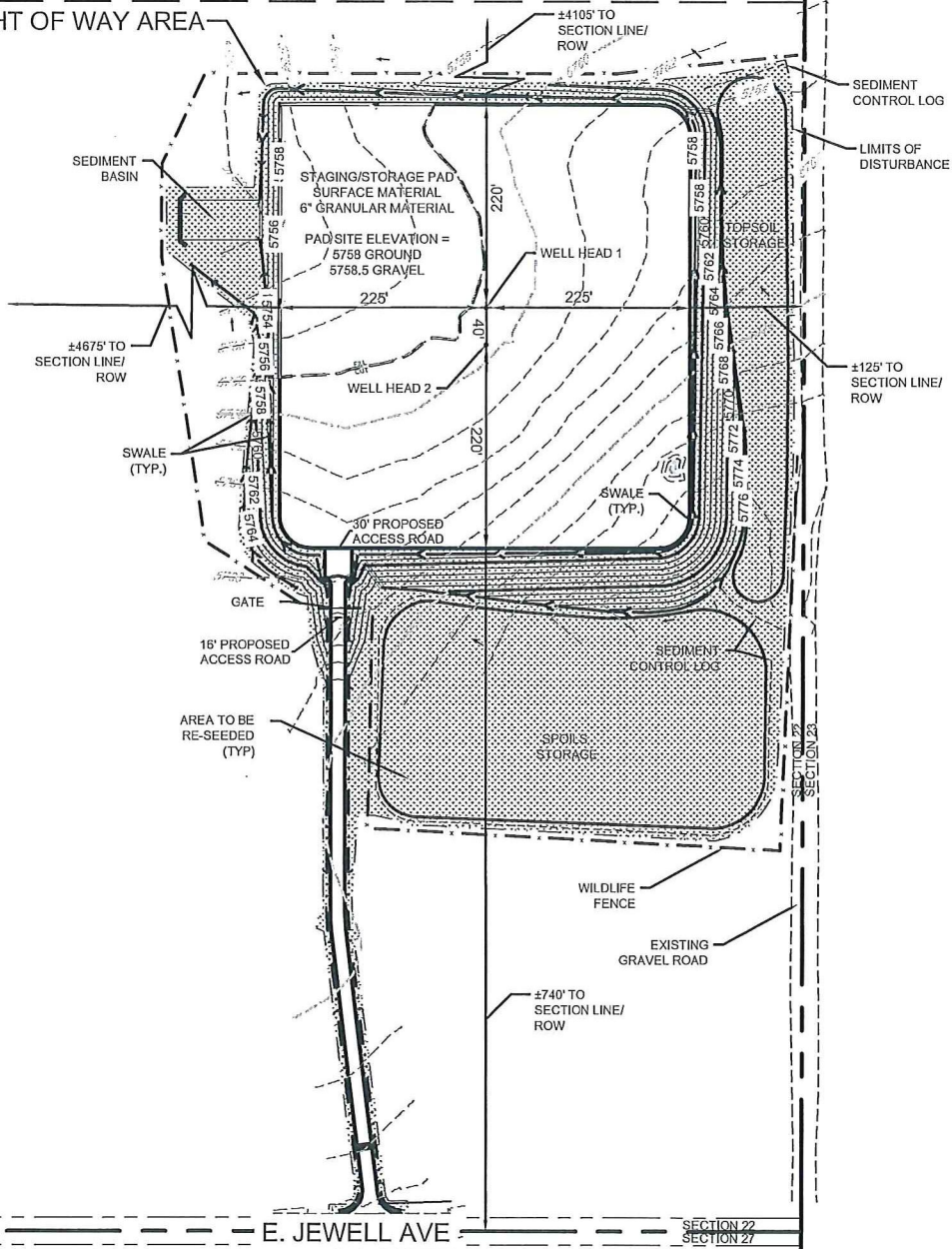
