COMMENTS:

Attached are the laboratory analytical reports and the sample location map for the historical produced water release which occurred at the WPX SG 43-28 well pad and was discovered on October 18, 2013.

Five grab confirmation samples were collected from the bottom and each wall of the excavation and one composite sample was collected from the excavated material. All samples were analyzed for contaminants listed in Table 910-1.

Three background samples were collected near the SG 43-28 well pad to establish cleanup concentrations for arsenic.

All constituents are below the COGCC Table 910-1 and the footnote 1 to the Table 910-1 with exception of the inorganics. Therefore, in accordance with COGCC guideline Q32 regarding inorganics, the SG 43-28 well pad will be covered with 3' of clean soil during final reclamation of the site in order to account for this exceedance.

With the impacted area and the excavated material in compliance with Table 910-1 standards for hydrocarbons, WPX respectfully requests closure of this incident.
