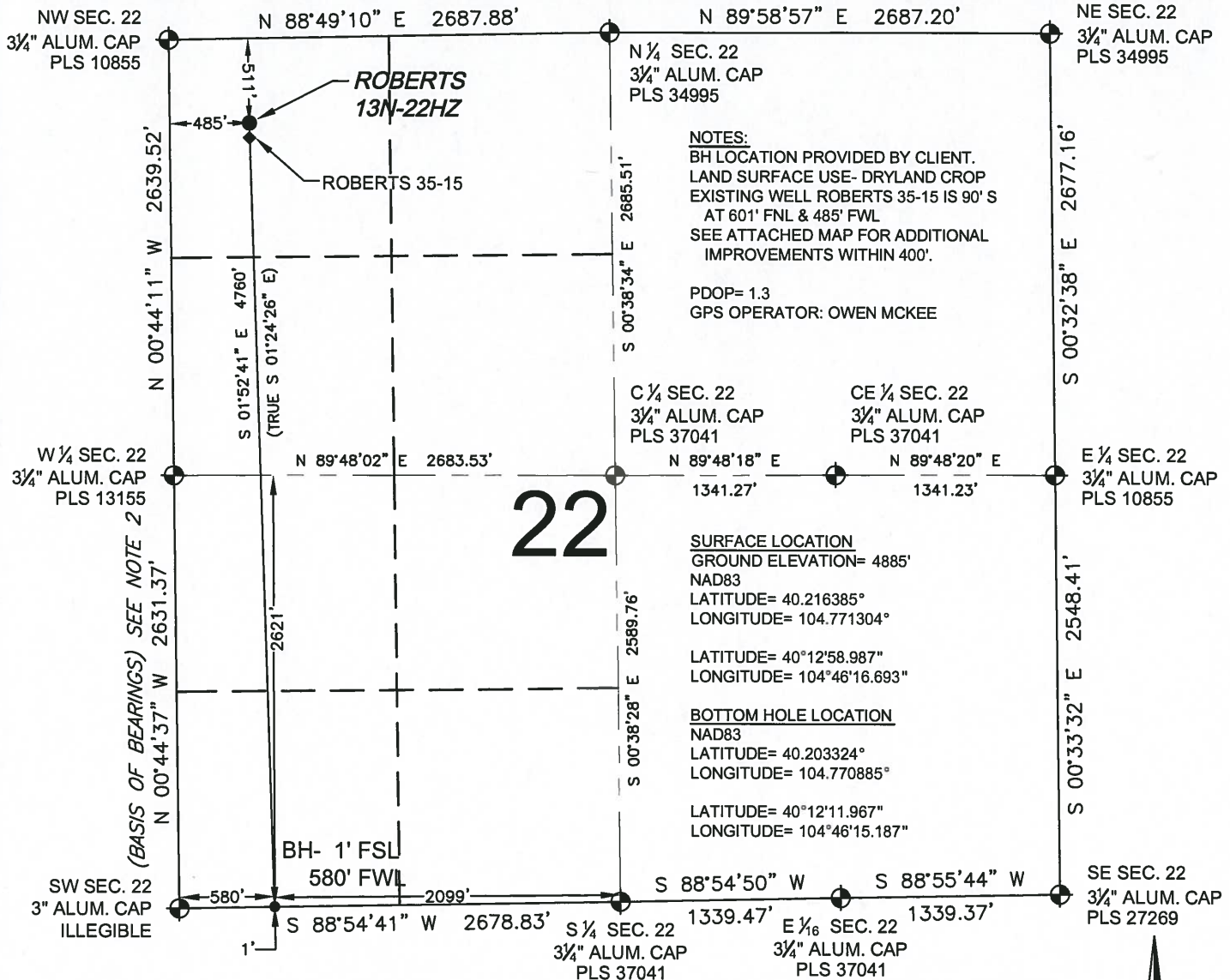


WELL LOCATION CERTIFICATE: ROBERTS 13N-22HZ

- = PROPOSED WELL ◆ = EXISTING WELL

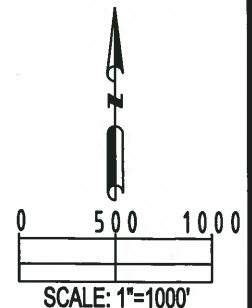
