Data from the Colorado Division of Water Resources indicates that there is currently one constructed water well and one spring located within 1/2 mile of the permitted YA-8 CO2 location. The well and the spring are currently registered to Michael L Reed. Ecosphere Environmental Services sent a hydrologist to speak with Mr. Reed in person on December 5th, 2013. Conversation with the landowner and a review of the spring location led the hydrologist to declare both the water well and the spring unfit for sampling. A surface water sample was taken downstream from the registered spring.
