The hauler was loading oil from a production tank at this location. He did not shut the loading equipment down timely enough to prevent the overfilling of the tank. When he disconnected the lines, the vent line released approximately 2BBLs of oil on the ground outside of containment.

CORRECTIVE ACTION

Describe immediate response (how stopped, contained and recovered): The driver used dirt and absorbent pads to stop the oil from spreading and called for a clean up crew.



Describe measures taken to prevent problem from reoccurring: The haulers should stay outside and watch the load from outside regardless of the weather conditions.
