Comments:

Interim reclamation activities were conducted on the Herring Draw 1-33 well pad location during autumn 2013. Interim reclamation activities consisted of berm stabilization and check dam maintenance. Activities also consisted of some surface roughening techniques, including pocking cut slopes, to enhance moisture capture and minimize erosion potential in preparation of hydroseeding.

On November 9, 2013, hydroseeding and hydromulching with Flexterra was conducted on the Herring Draw 1-33 well pad location cut and fill slopes and in spots along the access road leading to the well pad location. Hydroseeding application used a seed mix approved by the Routt County Conservation District for non-crop lands, RCCD #1 seed mix. RCCD #1 was applied on approximately 2 acres at an application rate of 48.4 PLS lb/acre for a total seed application rate of 96.8 PLS lb.

Additionally, noxious weed mitigation was conducted in September 2013 at the Herring Draw 1-33 well pad location to inhibit future noxious weed growth and infestation. Ongoing monitoring will be conducted in 2014 to determine the effectiveness of the autumn 2013 interim reclamation and noxious weed mitigation measures.
