This natural gas processing plant asset has been sold, will be dismantled, and the location will be abandoned. Historical COGCC records indicate an incorrect operator (Big Sandy Gas Company). Patara Oil & Gas LLC was the last and most recent owner / operator of the facility prior to its sale. A Form 12 has been submitted by Patara to update this information. September 18, 2003: Form 12 submitted by Cabot Oil & Gas Corporation designating Big Sandy Gas Company (subsidiary of Cabot) as operator of the facility. July 1, 2010: Purchase and sale of all Cabot (including Big Sandy) San Miguel County assets by Patara Oil & Gas LLC. July 2010: Plant shut down and "mothballed" by Patara with no gas throughput flows from plant. October 15, 2012: Purchase and sale of Big Sandy Double Eagle plant (no associate wells or pipelines included) from Patara to outside buyer. Plant began being dismantled from the site beginning in December 2012. A large quantity of equipment still remains onsite, and equipment will continue to be removed by the new owners over time. Patara will inform the COGCC at the time in the future when the site is ready for inspection. Please see included cover letter for further detail regarding the sale and abandonment of the facility. A plant plot plan has been attached. Thank you.
