There is adequate coverage above zones of interest, TOG, and planned top perf by 1,492ft. We have good/fair bond just short of MVRD, ~460ft short, with respect to our interpretation. We'd like to proceed with completion on this well, which is scheduled for 12/20/2013. I've attached the CBL for your review.
