- On 10/09/08 we ran in 2,668' of tubing, pumped 50 sacks of 15.8# cement with a yield of 1.15.
- On 10/10/08 tagged top of first plug at 2,024' Pumped 25 bbls of inhibited water at 2,020'. Perfed at 600' and squeezed 25 sacks of cement on 10/10/08.
- On 10/13/08 tagged top of second plug at 490'. Pumped 8 bbls of inhibited water, pulled tubing up to 210' and pumped 32 sacks of cement in the 51/2" casing. Pumped 20 sacks between annulus and surface casing. After 2 hours, cement in casing was within 2' of cut-off casing top. It was not observed to fall any further.
