WPX received verbal approval to conduct a micro-annulus squeeze on this water disposal well. WPX shot 6 shots in 1 foot perfs @ 6808'. We then squeezed with a balanced plug 50 sx of Finecem mixed at 12.7 ppg .86 ft^3/sack. We drilled out on 12/21/2013 and pressure tested to 3500 psi, held good. A wellbore diagram is attached.
