
Township 2 North, Range 66 West, of the 6th P.M.

AMENDMENT TO SURFACE DAMAGE AND RELEASE AGREEMENT

This Amendment to the Surface Damage and Release Agreement (this "Amendment") is made and entered into this 16th day of December 2013 by and between Lupton Sunrise L.L.P., ("Owner") with an address at 8791 Circle Drive, Westminster, CO 80031 and Encana Oil & Gas (USA) Inc. ("Encana") with an address at 370 17th Street, Suite 1700, Denver, Colorado 80202.

Whereas, Encana has the right to drill oil and gas wells (individually, a "Well") and the associated facilities on the lands described below (the "Lands"):

Township 2 North, Range 66 West, of the 6th P.M.
Section 34: East 1/2
Weld County, Colorado

Whereas, Owner is the owner of the above described Lands.

Whereas, Owner and Encana entered in to that certain Surface Damage and Release Agreement dated July 12th 2013 the ("Surface Use Agreement") to memorialize their agreement concerning the payment for damages to the surface of the Lands in connection with the access to and the drilling, construction, completion, recompletion, reworking, re-entry, production, maintenance and operation of the Well and all pipelines, tank batteries and other facilities or property of Encana or its affiliates associated with the Well and located on the above described Lands.

Whereas, Owner and Encana wish to amend certain provisions of the Surface Damage and Release Agreement as set forth below.

NOW, THEREFORE, for and in consideration of the covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Owner and Encana agree as follows:

AGREEMENT

1. Amendment to Exhibit "A". Exhibit "A" of the Surface Damage and Release Agreement is deleted in its entirety and replaced with the Revised Exhibit "A" dated 12/16/2013 and attached to this Amendment. The Revised Exhibit "A" dated 12/16/2013 attached shows the additional three (3) McConahay wells Encana intends to drill on the Owners property.

2. Execution. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original and when taken together shall constitute one and the same document. Facsimile and/or electronic copies of signatures shall be binding.

3. Effect of Amendment. Except as specifically amended by this Amendment, the terms and provisions stated in the Surface Damage and Release Agreement shall remain in full force and effect. This Amendment and the Surface Damage and Release Agreement, including all exhibits to such documents, constitute the entire agreement between the parties and supersede all prior and contemporaneous agreements and understandings of the parties. In the event of any inconsistency, the terms and provisions of this Amendment shall control over and modify the terms and provisions of the Surface Damage and Release Agreement.

4. Binding Effect. This Agreement shall be binding upon and inure to the benefit of the parties' heirs, successors and assigns.
