I converted the following from the lat/longs of COGCC web site USING this converter <http://www.apsalin.com/nad-conversion.aspx>

1479 FNL 187 FEL Lat/Long: 37.366658/-108.919341
ASSUMING NAD27 Which converts to NAD 83
37.3666505 and -108.920003

AND the "X" does not appear in the right place, based on the scaring of the surface aerial photo.
Old permits don't have lat/long – only footages – see docs # 549105 in the docs list.

The plat I find does not have a lat/long – attached.
I would have to guess that COGCC re-measured and gave the lat/long that exists in the file – in that it seems more reasonable than a converted lat/long? The footage measure based on the old plat to the map below appears more accurate than the "X"

I think it's best to use the COGCC lat/longs and put pdop 6? 8/21/80 HA CARSON – IT PASSES VALIDATION
