Jake,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have a few comments:

- 1) During my review, it appears the Land Use for this oil and gas location is not CRP Crop Land but Rangeland. Have you confirmed with the surface owner that this oil and gas location is on CRP Crop Land?
- 2) Because this oil and gas location is within the Northern High Plains Designated Groundwater Basin, it is by definition a Sensitive Area. Therefore, in the Water Resources section I will change the Sensitive Area designation from NO to YES.
- 3) In the Groundwater Baseline Sampling section, you have indicated that water well sampling is not applicable (N/A). Groundwater Baseline Sampling applies to all oil and gas wells permitted after May 1, 2013. For this location, the applicable Rule is Rule 609. Therefore I will change it on the Form 2A.
- 4) Due to the proximity of the intermittent stream located approximately 20 feet north of this oil and gas location, I would like to add the following Condition of Approval:
"Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the intermittent stream located 20 feet north of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."
