**COMMENTS:**

It is our intent to place cement in annulars to adequately cover and isolate any productive formations and ground water zones. (Codell formation in this well).This well was previously permitted and completed in the Codell and/or Niobrara formations, and as a result no additional permitting is required for gross perforated interval change. In the process of this operation it is PDC's intent to do some remedial cementing of the production casing. We have consulted the COGCC's engineering manager, Stuart Ellsworth, and prepared a workover procedure intended for this well as follows:

- MIRU
- ND production equipment
- NU BOP
- TIH clean out to PBTD with bit and scraper
- TOOHH laydown bit and scraper, pickup up packer
- TIH and set packer above top of perforations
- Pressure test casing to 5,000 psi (Maximum treating pressure for frac operations)
- TOOHH with packer and laydown.
- ND casing hanger and unseat casing
- TIH (annulus) with 1 1/8" workstring and tag TOC
- Place cement in annulars to adequately cover and isolate any productive formations and ground water zones
- NU casing hanger and reseal casing
- Run new CBL to be submitted to state

In the event the casing does not pressure test, then we will hunt the holes in the casing and repair prior to completeing annular cementing.
