Triton Energy Services respectfully requests a 90-day extension to the UIC permit for the Triton #1 well.

The well is expected to be spud between January 26, 2014 and February 1, 2014. Drilling is estimated to take approxiamtely 3 weeks. Completion operations will then commence immediately after drilling. It is expected that completion operations will be finished and ready for a mechanical integrity test between March 16-22, 2014.
